Pursuant to Regulation 51(2) read with Part-B of Schedule III of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, we submit the following:

Summary of the proceedings of Extraordinary General Meeting (EGM)

The Extraordinary General Meeting of the Members of the Company was held on Saturday, July 2, 2022 at its registered office situated at 1/1E, First Floor, East Patel Nagar, New Delhi-110008. The EGM commenced at 4:30 P.M. and concluded at 4:50 P.M. after transacting all agenda items mentioned in the Notice convening the Extraordinary General Meeting (“EGM Notice”).

The requisite quorum, as required under Section 103 of the Companies Act, 2013 was present. The Directors present at the meeting elected Ms. Ritu Kapoor Puri, Executive Director of the Company, as Chairperson of the meeting in terms of the Articles of Association of the Company and applicable Secretarial Standards.

Ms. Puri welcomed the Members to the meeting and introduced the Board members and Key Managerial Personnel of the Company, namely, Mr. Akhil Gupta and Mr. Vipin Chaudhary, Non-Executive Directors, Mr. Rajeev Lochan Agrawal, Chief Financial Officer and Mr. Manish Rustagi, Company Secretary, present at the Meeting. It was further informed that this EGM has been convened at shorter notice with the consent of all the shareholders of the Company, to ensure compliance of SEBI Circular No. SEBI/LAD-NRO/GN/2021/35 dated August 3, 2021 read with the corrigendum, to have shareholders’ approval on the appointment of Directors within three months from their appointments.

The members were informed that the Company had sent EGM Notice to all its eligible shareholders and other stakeholders to seek shareholders’ approval to the agenda items as per EGM Notice, which is approval for (a) Appointment of Ms. Ritu Kapoor Puri (DIN: 09559548) as Whole-time Director and Key Managerial Personnel designated as Executive Director of the Company, w.e.f. April 04, 2022 (b) Appointment of Mr. Akhil Gupta (DIN: 09285050) as Non-Executive Director of the Company, w.e.f. April 26, 2022 and (c) Appointment of Mr. Vipin Chaudhary (DIN: 09588893) as Non-Executive Director of the Company, w.e.f. July 1, 2022, in the manner as stated in the agenda of the said Notice.

With unanimous consent of all the members present at the meeting, the businesses, as set out in the EGM Notice, were put to vote by the members by show of hands.

All the businesses as set out in the EGM Notice were unanimously passed by the Members.
