

## TERMS AND CONDITIONS - DHANI DAY OFFER ON AMAZON

### 1. DEFINITIONS

- a. **User(s) or Customer(s) or You** shall mean and include any person who accesses and uses the Dhani Platform for services provided thereon.
- b. **Dhani Platform or "Dhani App"** shall mean the mobile application(s) available on the Apple Store and/or Google Play Store and operated under the brand '**Dhani**'

### 2. OFFER & OFFER PERIOD
